This was accepted by the members unanimously

3. The rules framed for the functioning of the school managing committee were unanimously passed.
4. The rules framed in regard to duties and responsibilities of the head of the school in confirmation with the Govt of Odisha and Central Board of Secondary Education were also unanimously passed.
5. It is also decided that the membership of Greenfield centre of Education and community Development should be limited to 11 members only.

6. TERMINATION OF MEMBERSHIP:- (a) In the event of a member of the centre ceasing to be Greenfield centre of Education and community Development (Greenfield School) he automatically ceases to be a member of the centre.

In addition to provision in this regard in clause above the membership shall be terminated if a member is found to be of:-

- (b) Unsound mind.
- (c) Found guilty by any court of law of any offence involving moral turpitude.
- (d) If a member is engaged in activities detrimental to the affairs and objectives of the centre.
- (e) An acceptance of resignation by the President.

The executive committee shall have the right to remove member failing (a) to (d).

7. TERMS OF OFFICE OF SCHOOL MANAGING COMMITTEE

The terms of the members of the Managing Committee shall be 3 years. A member can be re-nominated for another term but a member cannot remain in office for more than 2 consecutive terms except the ex-officio members and the members who are also the members of the society. The duties, powers and responsibilities of the school Managing committee shall be formulated by the Ex-Committee of the society. The School Managing Committee with the policy of the society.

8. AMMENDMENTS/ CORRECTION

Wherever it shall appear to the Ex. Committee that it is advisable to alter, extend or abridge for such purpose for which it has been framed or to amalgamate the centre either wholly or partially with any other society, organisation the Ex-Committee may convene a special general meeting for consideration thereof. For convening such a meeting the normal notice period of 14 days is required and resolutions passed in accordance with the rules of the centre. Addition/amendments and or correction to the bye-law can be made in the General Meeting of which intimation shall be sent to registering authority for incorporation in the bye-law.

The meeting was adjourned with thanks to all.
